



## EUNIS General Assembly meeting, 9<sup>th</sup> of June 2016, Thessaloniki

### Minutes

The annual meeting of the EUNIS General Assembly took place during the EUNIS 2016 Congress in Thessaloniki, Greece.

#### **4. EUNIS activities**

The Board and TF leaders reported on the activities and future plans of the EUNIS Task Forces. All Task Forces had run pre-Congress workshop on 7<sup>th</sup> June 2016.

##### **Benchmarking:**

The BencHEIT TF now has 57 members, taking part in the BencHEIT survey on IT expenditures. The next annual BencHEIT workshop is planned in Trondheim, Norway at the beginning of December 2016. New active participants are welcome, including members that would be willing to join the steering group. A closer cooperation with JISC and EDUCAUSE is expected.

##### **Interoperability:**

The TF currently runs the EMREX project, Erasmus without Paper and Techies bunch in the Groningen Declaration Network. There are approx. 120 members in the Task Force.

##### **E-Learning:**

There are approximately 100 members from 15 countries on the mailing list. The next workshop is expected at the Norwegian University of Science and Technology in Trondheim, Norway, possibly with the BI workshop. The TF is interested in a bid for an EU project.

##### **Business Intelligence:**

The BI TF is interested in joint/cross over events with the E-learning TF and webinars on BI issues within EUNIS.

##### **ERAI**

ERAI are developing a repository for the work published by ERAI and EUNIS provided by euroCRIS (Dspace-CRIS). Next year ERAI plans for case studies and interviews linked to current reports. Collaboration with other organisations such as EDUCAUSE, CHEITA and Internet2 as the European node are in progress.

##### **European Commission**

EUNIS is represented in Bruxelles by Yves Epelboin at the Education & Training 2020 Working Groups, especially the Digital skills and competences WG. EUNIS is involved in The Digitally-Competent Educational Organisation, developing a self-assessment online tool to assess digital competences and maturity of institutions and educators in using ICT.

##### **Rectors' Conferences**

The aim of these Conferences are to discuss strategy, policy, organization and management issues and are not IT focused.

##### **Rectors' Conference 2016**

Last April, the EUNIS 2016 Rector's Conference took place in Kraków, Poland, hosted by AGH and Jagiellonian Universities. Attendees were Rectors and decision makers from 43 institutions and representatives from 21 countries. According to the evaluation questionnaire, the event was rated very high.

##### **Rectors' Conference 2018**

The next EUNIS 2018 Rectors' Conference that will be held in Portugal on 26-28 April 2018, hosted by the University of Porto.

##### **2017 Münster**

The EUNIS 2017 Congress will take place in Münster, Germany, on 7 - 9 June 2017, hosted by University of Münster.

### Roles on the EUNIS Board

The President announced that the roles of Board members would be evaluated.

The General Assembly unanimously approved both past and planned activities.

### 5. Special report about a financial issue

The Treasurer had the difficult duty to communicate a significant financial fraud suffered by EUNIS.

Checking the accounts in early 2016, the Treasurer discovered a major discrepancy between the bank reports and the reports made by the Treasurer Assistant, Mr Harald Spiegl.

Confronted by the evidence, Mr. Spiegl confessed to having fraudulently obtained up to €96,758 from the EUNIS account.

The Board reacted immediately, removing Mr. Spiegl from his position, securing the account, and hiring a lawyer in Germany to determine the best legal route to follow.

The aims of EUNIS board were:

- 1) to recover as much of the money as possible
- 2) to keep a legal pressure on the Mr. Spiegl with the possibility to take an action to court at a future date.

A legal notary agreement has been signed by Mr. Spiegl on Tuesday 7<sup>th</sup> of June 2016, in which he confessed to the fraud and committed to payments of €500 per month until September 2020, and for a final payment of €104 500 in October 2020 (i.e. for a total of €130 000). These payments are secured by a land charge on Mr. Spiegl's property, and a submission to wage garnishment.

In addition, the Board decided the following actions:

- Establish double-verification on EUNIS online banking account by Board members
- Make monthly bank account statements available to all Board members
- Conduct an external financial audit ASAP in 2016 using a French auditor (EUNIS is registered in France)
- Establish annual internal financial audit by auditors elected by general assembly from EUNIS members starting in 2017.

The General Assembly unanimously approved the measures outlined by the Treasurer.

The President and the Board expressed sincere gratitude to the Treasurer for his efficient and effective management of this exceptional affair.

### 6. Financial report and budget

The Treasurer presented in details the cash report for year 2015-2016, which is summarized below:

The money fraudulently removed from the EUNIS bank account is not included in this cash report.

The bank balance on June 5<sup>th</sup> 2016 is €52529.24.

Estimation for September 30<sup>th</sup> is €35529.24. This takes into account legal expenses for the Mr. Spiegl affair (€21000), and a surplus from Rector's Conference 2016 (€7000).

Both reports were unanimously approved.

#### **7. Election of scrutinizers for the election of Board members**

Ivan Vrana and Kuno Öhrman were elected as scrutinizers.

#### **8. Election of new Board members. There were four vacancies.**

After a secret ballot (36 papers) the following were reelected to the Board:

After a secret ballot the following were approved as Board members having been co-opted during the year since the last General Assembly:

The General Assembly ended after the elections (no other issues were raised).
